- Extensive experience in compliance, legal, or regulatory roles within the Banking sector.
- Preferably 5 years' experience in a lead Compliance Role and/or at a Senior Management level
- Strong knowledge of banking laws and regulations.
- Excellent analytical, organizational, and leadership skills.
- Excellent understanding of KYC, CDD, SOF, and SOW requirements and risk controls relevant to the retail Banking sector
- Excellent working knowledge of FATCA and CRS regulations and requirements.
- Strong communication and interpersonal abilities.
- High degree of computer literacy, particularly in the use of the relevant software packages (e.g. Microsoft Office Suite)
- Incumbent should have retail Banking experience.
